To learn more about your coverages, view our attorney network or grant your dependents access, create an account.

For a monthly cost,* you get legal assistance for some of the most frequently needed personal legal matters — with no waiting periods, no deductibles and no claim forms when using a network attorney for a covered matter. And, for non-covered matters that are not otherwise excluded, your plan provides eight hours of network attorney time and services per year.³
